## New and changed in this release

### Important note for users of the SMS Web API authenticating with URL encoded credentials

This patch changes what data SMS debug logs include when logging web access requests to exclude those credentials. For details on this change and best practices, refer to [PB#1071](#).

### Important notes for SMS

- Patch installation should take approximately 15 minutes. During installation, the SMS client will become unresponsive; do not cancel the operation or reboot the SMS. The SMS Server will automatically reboot after the patch is installed. You will then be prompted to update the SMS client.
- A patch may be rolled back or uninstalled to the previous version.

- If your SMS system is operating in High Availability (HA) mode, you are no longer required to break HA to apply this patch.

SMS	The results of a DV packages search are now sorted with the most current DV package listed at the top.	117792
SMS	The remote syslog has been enhanced with new format options.	116903

### Devices

Device	Description	Reference
SMS, TPS, IPS, Core Controller	When HA is disabled in an SMS cluster, an API that changes the SMS serial number would get called by the Passive peer instead of by the Active peer. All managed devices would then appear to be managed by both SMS devices in the HA cluster.  This patch resolves this issue.	118005

SMS	An issue that prevented the SMS from sending some events to a syslog server (for custom event queries) has been resolved.	103834

SMS	<p>If a Nexpose vulnerability scan (eVR) file contained extra characters for a CVE-ID, the SMS was not able to correctly parse the vulnerability scan data.</p> <p>Imported Nexpose scan files that contain extra characters for a CVE-ID are now supported by the SMS.</p>	120132
SMS	<p>An issue that caused a table (related to the Reputation feature) to fill up and the SMS to slow down or hang during device discovery or profile distribution has been repaired.</p>	118407
SMS	<p>Some filter overrides would remain as part of the security policy even after the profile with the filter overrides was deleted. These orphaned overrides would prevent activation of new DV versions.</p> <p>This patch resolves this issue and enables successful DV activation without errors.</p>	118313

SMS	<p>The Data Dictionary API that had tags that were never closed has been repaired.</p>	119848
